My internship at the Department of Justice's Executive Office for Immigration Review (EOIR) has been great! I've had the opportunity to work on an incredibly diverse array of projects, including responding to discovery requests, drafting litigation documents, and working on attorney discipline projects. I've also had the opportunity to attend immigration hearings at the Arlington Immigration Court. I. learned about the ways individuals may seek to cancel removal, the rights of legal permanent residents and aliens versus the rights of U.S. citizens, asylum applications, and the role EOIR plays in immigration legislation. I also learned daily from the attorneys I worked with and obtained a lot of career advice. I enjoyed the experience so much that I decided to continue my internship this fall. I am happy to report that my summer internship at the U.S. Department of State, Bureau for Democracy, Human Rights, and Labor (DRL) was a huge success! I was able to conduct legal research on a variety of issues relating to sensitive grantees in high-risk countries. I also spent a significant amount of time conducting research under the broad theme of transitional justice, including drafting a memo on the office's "access to justice" programming and broader considerations that should be noted to further access to justice. I also advanced my understanding of FOIA exemptions by working on a FOIA request and determining the legal basis for which specific redactions were warranted.

Looking back on this internship, I learned a lot about the practical implications on programming by the U.S. government. I also learned a great deal about how the Department of State Functions internally, and the various opportunities to find employment there.

The past ten weeks with the D.C. Rental Housing Commission. proved to be both more challenging. and rewarding than I could have. imagined. On my first day, I was given the task of drafting a decision for a case that came before the Commission over five years ago, illustrating the incredible backlog that many such local administrative agencies have. In the process of writing and revising opinions and orders this summer. I learned a great deal about housing problems in the District as well as the intricacies of the D.C. Administrative Procedures Act. In. addition to honing my writing skills, I was able to observe firsthand the difficultly that pro se litigants face in raising and. defending claims against counsel before the Commission. My experience this summer has inspired me to continue to study the effect that being pro se has on the outcome of claims brought before adjudicative bodies, and I hope to ultimately find a means of helping. pro se litigants draft and present their cases to courts. Without the support of SABA, I would have never been able to pursue such a path, and I cannot thank SABA's members for their generosity.

Monthly Dinner Series

May Dinner

On May 22nd SABA-DC welcomed Raj Dave and William Simmons to speak about the landmark Supreme Court case—*Association of Molecular Pathology v. Myriad Genetics*. This dinner series event took place prior to the Supreme Court's ruling and the two speakers discussed the patenting of two human genes linked to breast and ovarian cancer as well as the implications for science and research. The event was a great primer for the issues in front of the Supreme Court, which eventually ruled that simply isolating genes is not eligible for patent protections.





June Dinner

On June 18, SABA-DC welcomed Sandhya Bathija, Campaign Manager for Legal Progress, to speak about the role South Asian attorneys can play in shaping the federal judiciary. We had a full house for this event and were able to have an extensive discussion on the issues impacting South Asians before the federal courts and how we, as South Asian Attorneys, have the opportunity to ensure our judiciary is fair, functioning, and diverse.

July Dinner

On July 9, SABA-DC hosted a dinner featuring Tejinder Singh, a SCOTUSblog contributor and counsel at Goldstein & Russell, P.C., a boutique law firm focusing on Supreme Court cases. The discussion focused on the landmark Supreme Court decisions on issue of same sex marriage, affirmative action, and more. Tejinder offered unique insight into the Court's decision-making process as well as about the work of his firm. He also fielded numerous questions from the attendees on a broad range of Supreme Court issues and rulings.

August Dinner

On August 28, SABA-DC welcomed Erin Oshiro from Asian Americans Advancing Justice (AAJC) to speak about S. 744, the Senate Immigration Bill and the status of comprehensive immigration reform. Erin explained all of the critical aspects of the Senate Bill and what the status of reform is in the House. Night with the Nationals


